Victoire pour les liberaux

There are approximately 35 Glendon students on the waiting list for rooms in the two residences here, and a proportionately large number of York students (about 500) are waiting for residence rooms at the Downsview campus. The quantity of affordable housing being demanded in Toronto at the moment is large, with the supply of housing suitable for university students relatively limited, and the price level of appropriate dwellings high.

This situation has put the Dean's Office, under the auspices of Master of Wood and Hilliard Residences and Dean of Students Yvette Szmidt, in a unique and powerful position. The Dean's office can now be very selective in choosing the people who will live in residence, by enforcing the Residence Contract prescriptions to an unprecedented extent.

This selectivity has gone past the annual and necessary elimination of extremely undesirable residents; academic performance, number of courses taken in the previous year, home location, and date the \$200 residence deposit was paid, as well as the usual focus on student's behaviour have been the most common reasons for refusing rooms to returning students. First year or new applicant's names go on the waiting list if they are not in luck; many out-of-town people find themselves in this unhappy situation as the academic year begins.

Such strict enforcement of the Residence Contract is a new development at Glendon College, which is known for its compassionate and personal relations with its residents.

The root of it lies in the actions of York Housing in the mid-1970's, when very few Glendon students wanted to live in residence. Enrolment was low, and the Toronto housing market was kinder to students. Entire houses were being closed in Hilliard because of ing room allocation are excluding deserving Glendon and York students from Wood and Hilliard, policies largely determined by York Housing, which is not particularly interested in who lives in its buildings as long as they pay rent, and by Glendon's administration, which has to ensure office space for the professoriate.

Although Dean Szmidt is not herself responsible for the historical background to the present situation, she is responsible for the actions of her office, which are not at all reassuring to students.

Why were ten new CMCC students assigned rooms at Glendon this year, when economic conditions and rising enrollment were pointing to a September housing crisis for university students? With no written reason for accepting non-York people over York people, it would seem that priorities have gone somewhat awry.

It is honorable and proper to fulfill our obligations to returning CMCC students, providing they are judged by the same criteria which applies to Glendon resident students. However, it is appallingly bad judgement to accept new non-York people into residence over first-year or deserving Glendonians whose only transgression was an unsatisfactory G.P.A., course load, or late payment of If the element of compassion is lost in dealing with Glendon residents, then it cannot be said that Glendon is "different" because it is small. If "smallness" is supposed to mean that a human face is put on affairs, then that is being lost. If Glendon students' names are being arbitrarily crossed off the list of students eligible to return to residence and put on a waiting list, then that is no different than the actions of the most impersonal bureaucracies.

Next year will be the first year in which Ontario secondary school students from Grade 12 as well as Grade 13 will be eligible to apply to Ontario universities. In that scenario, this year's student housing crunch is going to look like a glut.

It is time for York student leaders to start looking after their interests in the housing situation; it is obvious that no one else will. Action should be taken to ensure that deserving Glendonians and York students get priority in residence.

Escott Reid, the first principal of Glendon College, saw us as a *residential*, bilingual college; we must never forget this. That is why the Principal lives on campus; that is why the Dean lives on campus; that is why Glendon and York students *should* live on campus.

Free TradeAwakens U.S.

A Free Trade pact could be the most important agreement Canada has ever considered because it could affect every single aspect of our lives. We must never underestimate what is at stake in these negotiations: Nothing less than our sovereignty as a nation. Our ability to make decisions that will chart Canada's course into the 21st century. One of my concerns about the current trade negotiations is that we may deprive ourselves of the tools we need to strengthen Canada's economically disadvantaged regions. In March, 1985, Prime Minister Mulroney and President Reagan agreed to free trade negotiations, without prior discussion in Parliament or in the country. Two years later in March of this year, Parliament had its first debate, for only one day on this vital subject. The Conservative strategy was and still is to keep Canadians ignorant of what was being discussed in the negotiations, and Mulroney has given no details as to what is and what is not negotiable. In May, 1986, the Canadian Government released 24 Trade Enhancement Studies, but all details as to impact on certain sectors and regions were deleted. For the last two years the Conservative Government has called the negotiations by different names, freer trade, enhanced trade, etc. But recently Mulroney and company are calling it Free Trade, and for convenience, so will we.

Mulroney wants to give no details of the Free Trade negotiations and asks Canadians to trust him, and give him a free hand to get a good deal for Canada. But it is difficult to trust a Prime Minister who sold out our fishermen in the Gulf of St. Lawrence to France, the pharmaceutical industry to the U.S. (regardless of what the "old men" in the "other place" try to do), who tried to de-index Old Age Pension, and who dismantled FIRA and the National Energy Policy before Free Trade bargaining began. Will Free Trade affect our Agricultural Marketing Systems, including financing through the Farm Credit Corporation, advance payments by the Wheat Board, subsidize freight rates? Is the Auto Pact on the table or not? If tariff on auto parts and vehicles are given up, the auto pact becomes meaningless. Will Mulroney protect "our cultural identity" in the same manner as he allowed the Prentice Hall Publishing takeover by U.S. companies? How will Free Trade affect our regional equality programs? Under Free Trade would Canada still be allowed to help the grain farms by a \$1 billion subsidy, to help the oil and gas industry by \$350 million, or have a Cana-

almost guaranteed a monthly headline of recent victims crushed by this elephant.

Americans like to talk of fair trade and a level playing field. But they are really talking about a field with their linesman, their lines, their rules, their ball and their referee. The Americans change the rules when they find they are losing. By using the unilateral countervailing system, as in shakes and shingles and softwood lumber which will cost Canadians at least \$600 million. The Rt. Hon. John Turner believes that any agreement with the U.S. that does not severely limit or eliminate the use of countervailing action will not be worth the paper it is written on. Canada needs more emphasis and financial support for research in post-secondary education, and apprenticeship to take advantage of new opportunities in the market place of the world. A trade agreement is no substitute for for a lack of an economic policy on productivity, of getting us to work smarter, think smarter and to compete around the

vacancies.

York Housing decided, in concert with the Executive Committee of Glendon College, to allocate some of the empty rooms to Glendon faculty as office space, and to rent the rest of the surplus to students from the Canadian Memorial Chiropractic College; however, no written agreement was struck between CMCC and York Housing.

The result of this is that there are now two residence houses which presently are not occupied by either Glendon or York students; CMCC students comprise the population of C-House Wood, and D-House Hilliard is occupied by professors' offices.

Given this background, it is clear that the policies surround-

dian first hiring and procurement policies for mega-projects like the Hibernia oil fields?

I, personally, don't believe Canadians from disadvantaged regions should have to move to Toronto or Montreal to find jobs. I believe in equality of opportunity wherever you live in Canada, equal opportunity employment, education, and a secure retirement. However, Mulroney has awoken the sleeping elephant. As the giant begins to stretch its muscle, we in Canada feel the deadening effect of protectionist measures. Please don't forget that protectionist measures have been rare in Canadian trade but within the past two years of American enlightenment the Globe and Mail is

Take Back The Night

RG goes to York

Radio Glendon is in the midst of a major physical renovation, under the direction of manager Mike Fraser, and Ted Telford, Dave Shantz and Chris Bennett. The new layout brings RG's set-up into line with other campus radio stations, and is part of the development ;of an hour-long bilingual show which will be broadcast on CHRY Radio York.

In mid-October, Radio York will begin broadcasting on a CRTC-licenced 50 watt transmitter. RG's show is in the planning stages; it will be a bil-



ingual vehicle for the promotion of new French-Canadian and English-Canadian artists, and the discussion of current affairs and politics by Glendon faculty and students.

There are about six weeks in which to prepare for the regular production of the taped show. It will take about seven or eight people to produce and direct the weekly, hour-long show.

Mike feels that university radio should provide practical work experience in the broadcast industry to all interested and motivated students, and that musically, a university radio station exists to help promote new artists, local and national, in different musical areas: folk, jazz, blues, classical, as well as alternative pop.



In 1980 Barbara Schlifer was raped and murdered outside of her Toronto home. After this incident hundreds of women protested (for the second year) the violence that women and children are forced to endure and to draw attention to our struggle to stop the rape and assault of women and children. This protest has been named Take Back the Night and similar marches and rallies have been occurring annually for eight years in cities across Canada.

This year Take Back the Night will be on Friday September 18th and will consist of a rally which begins at 7:00pm at 519 Church St. (at Wellesley), followed by a march and coffeehouse at the Central Neighbourhood House on 349 Ontario St. The coffeehouse will be featuring such performers as Arlene Mantle and Lillian Allen. It will be wheelchair accessible and interpreted for the hearing impaired.

The celebration continues on Saturday the 19th when there will be a dance at the party cenredia Quote Magazine



tre at 167 Church St. Tickets are available at the Toronto Women's Bookstore and will be on sale at the Glendon Women's Network table on clubs day Thursday September 17th. The dance is wheelchair accessible and all women are welcome.

Every year as well Take Back the Night has a theme and a series of demands. This year's theme is "Women Demand Safe and Secure Homes", The demands are:

- homes free of rape and battering and incest which affect one million women and children.

- homes for low income women and their families so that we all have choices about living safely in affordable housing (average rent for 1 bdrm apt+ \$840).

- shelter for women who have no place to go and who otherwise are forced to live on the streets (at least 100,000 homeless in Canada).

- safe humane housing for older and disabled women who are too often victimized in public and private nursing homes and hospitals. - accessible housing for expsychiatric patients who are frenquently abused by landlords and inhumane living conditions.

world. The Mulroney Government has abandoned this kind of policy, putting all its eggs in one basket, by relying on Free Trade with the U.S. as Canada's sole salvation. The Rt. Hon. John Turner has summarized the Liberal position by stating that it is opposed to an all-inclusive Free Trade Arrangement, which would undermine Canada's political, economic and cultural independence. If a less comprehensive trading agreement can be obtained with the U.S., it should ensure greater access to U.S. markets by severe restriction of U.S. countervail and non-tariff barriers. It should also ensure Canadian independence of domestic programs, policies, and legislative authority in social policy, agricultural marketing, subsidies and assistance

for regional and industrial programs including high technology development, the Auto Pact, the environment, biculturalism culture, and financial and service industries. Perhaps it is easy to sit on Opposition benches and simply criticize and propose unworkable solutions, however, it appears that this time the Liberal party has a clear vision on this issue. By September 1987 the details of the Free Trade negotiations will at last be revealed. The tough questions can be answered and the practical advantages and disadvantages assessed. It is the responsibility of all Canadians to become familiar with this issue and take a position because the ramifications of a Free Trade deal will affect all of us in Canada in almost all aspects of our lives.

New Anti-Porn Bill Endangers...

The Federal Conservative Government proposes to introduce new legislation, Bill C-54, intended to make the enforcement of anti-Pornography laws more effective. While few would contest better actions to combat the sexual exploitation of children and women, a great deal of opposition has been levelled at Bill C-54 in recent months. The spectrum of opponents (Artists, Writers, Gay and Lesbian Activists, Feminists) argue that the proposed censorship of sexually explicit imagery would endanger much more than obvious images of sexual exploitation. The construction of Bill C-54, opponents say, renders it unable to stop sexually demeaning imagery in general and too restrictive for Artists and Sex Educators.

Bill C-54 was given its first reading before the House of Commons on May 4th of this year by Federal Justice Minister Ramon Hnatyshun. Mr. Hnatyshun's legislation attempts to correct the problems in the anti-Porn document proposed last June, by then-Justice Minister John Crosbie. Mr. Crosbie's proposal presented terms such as "offensive, indecent, and other sexual acts" as contrete, legal definitions for the official attack on Pornography. These terms accurately described some of the ethical grounds on which to oppose Pornography, but their open-endedness made them both ineffective and dangerous for legal application.

Mr. Hnatyshun has replaced the sweeping moralisms of Mr. Crosbie's draft with a more specific position on what constitutes Pornography. As with


having sex as the enemy."

trouble is that we didn't really get far enough away from having sex the enemy." The reason for this one-step-forwardtwo-steps-back position is the range of sexual explicitness allowed for by Bill C-54's definitions:

Erotica means any visual matter, a dominant characteristic of which is the depiction in a sexual context or for the purpose of the sexual stimulation of the viewer, of a human sexual organ, a female breast, or anal region.

The between-the-ears nature of "sexual stimulation of the viewer" and use of "sexual context" which is present in the painting King Kong by contemporary Artist David Sallé, as contrasted with the between-the-legs nature of these photos which separate the articles of Penthouse magazine, is irrelevant to Bill C-54's definition of Erotica. Mariana Valverde, a Feminist writer who is vehemently opposed to Bill C-54, outlined the importance of considering a work's context in attempts to define "Erotica" in her book Sex, Power and Pleasure.

When we look at a Playboy centrefold we generally see a young white woman with a flawless body; she is either sitting or reclining, her genital area is exposed in a purposeful manner and is usually in the centre of the picture. In itself, the picture does not have very much meaning. We supply most of the meaning ourselves, from our experience of living in a sexist, ageist and racist society, and from our general knowledge of what Playboy is and what is expected of the viewer. We know from sources outside the magazine that it is not coincidental that the woman in the picture is young, slim, white, and helpless-looking.



Questions of social context are also ignored in Bill C-54's definition of Pornography:

Pornography is any visual matter that shows:

- sexual conduct that involves or is conducted in the presence of a person who is, or who is depicted as being under the age of eighteen years.
- The exhibition, for a sexual purpose, of a human sexual organ, a female breast, or anal region of, or in the presence of a person who is, or is depicted as being or who appears to be under the age of eighteen years.
- □ sexually violent conduct including sexual assault in a sexual context.
- A degrading act in a sexual context whether or not the other person appears to be consenting to any such degrading act.
- □ lactation or menstruation in a sexual context.
- bestiality, incest, or necrophilia.
 masturbation, ejaculation or
- vaginal, oral or anal intercourse.

authoritarian. A prosecuting attorney has to establish that a creation before the courts contains one or more of the actions defined as "Pornography," and the work is seized by the state.

Bill C-54's more specific definitions of Pornography would ease the process of evaluating seized Pornography in Metro Police/O.P.P. Squad whose mandate is enforcing anti-Porn laws) has been quoted as saying in reference to the enforcement of anti-Porn laws.

The definitions of acceptable and offensive sexual imagery in Bill C-54 has lead to many arguments over who the targets of the proposed legisla-

the Courts but it is doubtful whether or not the proposed Bill would benefit a crackdown on Porn. In the case of themost vile subgenre of Hardcore Pornography, Child Pornography, determining the "Obscenity" of the material has not been the cause of the enforcement problems. The absence of plot, developed characters, settings, or motivation beyond sexual pleasure and the psychotic intensity of the perversion and intensity of the sexual actions which typify the Hardcore Porn genre in general make legal evaluations with such imperfect criteria as an "undue exploitation of sex" an easy task. The stumbling block in the crackdown on Porn has been locating the exploitive material. Extreme depictions of sexual abuses against children circulate through a tight network of distribution and Production. A handful of key people are involved in generating the \$8 billion that flows through North America yearly. "It's underground — it's not as visible as, say, Adult Pornography," Staff Sargeant James Hutchinson of Project Pornography (a tion will be. "They consider that pornographic, we consider it erotic," said Louise Dulude, President of the National Action Committee on the Status of Women. The NAC plans to lobby the Federal conservative Government to include vaginal, anal and oral intercourse in the category of acceptable sexual imagery (Erotica).

Those charged with creating or exhibiting material deemed Pornographic have one defense open to them before the courts. The defense of "artistic, education or scientific merit" is available to all charged as Pornographers under Bill C-54. This defense is dependent on certain conditions. "Bill C-54 doesn't automatically give us the right to educational merit," says Dr. Barrett. "Anybody who says 'I find the films that Barrett uses in his course offensive can lay charges against me. I could easily be charged under a number of sections. One, for showing something that is obscene (exhibition of Porno-

Mr. Crosbie's legislation, the focus remains on "Visual Matter." The sexual context of of the visual matter is now divided into two categories. Socially acceptable sexual imagery is classified as "Erotic." Unacceptable representations of sexual actions are deemed "Pornographic."

Dr. Michael Barrett (Chairman of the Sex Information and Education Council of Canada [SIECAN] between 1972 and 1985 and currently a U of T professor) said, during the course of an interview: "The attempts to distinguish between Pornography and Erotica are, at least, a move towards the notion that sex *per se* is not the enemy. The

We know from our own experience that the photo was created for a male audience and that when a man looks at it he will react in certain specified ways. He will not merely glance at the photo as he would at a landscape or a family photograph; he will gaze intently, stare at, and possess that woman with his eyes. We also know, from our knowledge of how capitalism works, that the purpose of the publication is not to celebrate the female body but rather to use female bodies to make profits. Thus, we use our knowledge of both the production and the consumption processes involved in pornography to interpret the picture and ascribe to it a meaning.

The Canadian Criminal Code of Canada does not presently contain a definition of Pornography. Questionable sexual imagery is presently dealt with, in legal circumstances, by referring to the Nation's Obscenity Law. Criteria such as "undue exploitation of sex" and judicial innovations of "contemporary community standards" has made the Obscenity law a frequent source of controversy. "Imprecise definitions lead to authoritarian interpretations of the law," says Toronto Barrister Ray Hughes. Bill C-54 provides little room for interpretations, be they egalitarian or

In isolation, the extreme sexually violent conduct in Kubrick's A Clockwork Orange is repulsive. The way that the scenes following the rape analyze the actions of the rapist in psychological, religious and socioeconomic contexts does not automatically legitimize the rape imagery. The deconstructivist structure of the film does, however, call into question the criteria used to classify A Clockwork Orange as being without social merit.

dents about the ideology of Pornography would be complicated by the nature of the social merit defence itself. The defence is an amendment to an existing Government document. The Charter of Canadian Rights and Freedoms states that an individual is innocent until proven guilty. Under Bill C-54, an individual is guilty of a Pornography offence until they can satisfy the courts that the work in question is innocent of the label, given its social merit.

This reverse onus (guilty until proven innocent) is Bill C-54's most problematic feature, and has been the focus of criticisms from both Legal and Artistic groups. "That criticism is warranted," said Toronto lawyer Ray Hughes, "since it goes against the whole history of criminal law. It's a constitutional problem and one that lawyers and judges will be up against when the Bill becomes law."

Those who will be on the other side of the bench, Artists, and sexual rights advocates, are equally concerned with how the social merit defense will be applied.

Bill C-54's absence of references to the larger context in which sexually explicit imagery appears complicates the defense of artistic merit. A prosecuting attorney could easily establish the presence of actions deemed Pornographic in many of the cinema's seminal works. Michelangelo Antoninioni's Blow-Up, Ingmar Bergman's Virgin Spring, Frederico Fellni's Amarcord and 81/2, Stanley Kubrick's A Clockwork Orange, David Lynch's Blue Velvet, Pier Pado Pasolini's Oedipus Rex, Martin Scorcese's Taxi Driver, Franco Zefferelli's Romeo and Juliet. all of these films contain scenes which show conduct deemed as Pornographic under Bill C-54.

The question "What is Art?" has been unresolved since the days of Plato. The personal nature of Art Criticism and the need for concrete evidence demanded by the legal process is a basic problem of Bill C-54's defense of Artistic Merit. By ignoring the context of sexual imagery, Bill C-54 would restrict Artists from criticizing the ideology of sexual discrimination with the same imagery of that discrimination. A growing number of Canadian Artists and Arts Organizations view Bill C-54 as an attack on one of their fundamental social rights. "The federal government is playing fast and loose with freedom of expression. Toronto-based filmmaker David Cronenberg has said. Cronenberg, President of the Ontario Video and Film Appreciation Society, says he would leave Canada should Bill C-54 become law.

In the existing social climate of sexual hysteria caused by the Acquired Immune Deficiency Syndrome (AIDS) plague, there is a desperate need for critical and explicit sexual imagery. To counteract the spread of the AIDS virus. health officials have been try-

Evidence from the Psychological Community is often trotted out to add academic credibility to the value judgement about the regulation of Porn that is being defended. This evidence is often in direct contradiction with other, equally documented findings. The problem arises when a direct link between exposure to Porn and committing violent sexual actions is attempted. No disagreement about the basic connection between Pornography and anti-female thoughts, perceptions and fantasies still circulates amongst Psychologists. The extent of this connection continues to be bandied about and, invariably, leads to dismantle the tory evidence about the Pornaggression link for a measuring stick for the extent of the connection.

Some studies prove an increase in anti-female aggression occurs among male subjects following exposure to misogynist pornography. Procensorship positions use such findings to reinforce the need for greater social protection from the anti-social reactions of male viewers.

The categories of Erotica and Pornography do not separate acceptable and offensive representations of sexuality with clarity. The defense of social merit is both unconstitutional and fatal to future critiques of the ideology of Pornography in anything other than legal terminology. These limitations give Bill C-54 consequences, halting the anti-AIDS campaign while doing little to strengthen the crackdown on Kiddie Porn, which contradict the basic intentions behind its conception. For these reasons, Bill C-54 should not become law in its current form.



Live In Liverpool


