# **Chedington opposed**

Chedington Holdings Ltd. has recently r.designed their deve opment project such that the two proposed housing towers are to be increased in height and located nearer the Glendon community.

Harry Arthurs, President of York University, met with representatives of the Holdings group last Friday. November 30th at the Glendon campus. During their discussion Arthurs tried to persuade the developers against carrying through with these new proposals.

"This meeting was unsatisfactory.' commented Mary Lynn Reimer, York's Master Planner.'They (the developers) don't want to do a lot.' She explained that this new design. partment Housing development. which calls for the height of the southern most tower to be increased to a height of 176.2m. concerns the university becau.se of the negative visual impact it will now have on the Glendon campus. Increases in height stem from a redesign that allows for more generous floor to floor heights and the addition of

penthouses. University administrators are now consulting legal council in order to determine the best possible route to counter these new proposals.

The development in question is planned to be built behind the Chedington Mansion which is located beside the main entrance to the campus. The Bayview Ave bridge to the west, the Glendon property to the east, and McLaren Ave (the road in the valley) to the north would make up the other boundaries of the project. On May 2 of 1988, North


On May 2 of 1988. North York City Council revoned this property RM6 (Residential Multiple-Family Dwellings) after an application for this purpose was submitted by Chedington Holdings Ltd.

Under the stipulations of this zoning category construction up to a density of 160% of the lot area, recreation facilities, and a parking structure are permitted. The original application proposed a two tower family dwelling of nine and ten stories, with a total of 69 units, and an average bulk of 3100 ft<sup>2</sup>.

At that time the Bayview-Lawrence Environment Protection Association (BLEPA) appealed the decision to the Ontario Municipal Board (OMB). Although, faculty members and students participated with this association. York University refused to take a position on the issue.

BLEPA argued before the OMB that the development would destroy the unique semirural nature of the area by creating site pollution from within the valley and from the Bayview bridge. They requested that the project be kept to a three or four story building

The OMB eventually upheld the North York City Council decision and the project was allowed to proceed.

## Moving towards a greener Glendon

In all, it was evident that this first meeting was long overdue. Students who had individually initiated recycling projects in their respective residence houses expressed frustration about the various obstacles and inefficiencies they had come up against. This made it clear that a more unified college-wide program was necessary in order for the frustrated efforts of individual students to be coordinated to provide Glendon with an effective, compreciensive

environmental program. Yet the administration did not express this same sense of urgency. Instead of specific dates being given for the implementation of projects discussed, the traditional "we'll look into it further" was assured. If the students of Glendon believe that a co-ordinated recycling and conservation program is important, then they should make their views known. Without the support of the student body, the admin-istration will be led to believe that it is just a small handful of crazed students concerned with such environmental causes.

The only way to bring about change is to show that the Glendon community wants change. Support and suggestions can be made through your residence house representative or addressed directly to Leon Wasser. Business Office Manager. The next meeting will take place Tuesday December 11 at 4:30 pm in Leon Wasser's office, Glendon Hall. All are welcome.

## Handicap facilities need improvement



Handicap facilities given an "okay" rating by users.

Although recent changes have been undertaken, there are still improvements that could be made to Glendon's facilities for the physically handicapped. Whether these improvements are made in the future. however. depends heavily on government funding. In an interview, Tania Sala, a Glendon student who uses a wheelchair described some problem spots on campus.

Except for lecture hall 129 classrooms are not a problem.

Tania said. The steps at the entrance of the lecture hall make it impossible for a person in a wheelchair to enter this way. In order to avoid these steps one would have to go outside, through the doors by L'Arcade and follow the little path to a set of doors at the rear of the hall. Since these doors are locked, a person from the inside would have to be waiting to open them. In the winter this is especially inconvenient. One particular concern was in the case of fire. Elevators are not to be used at this time and this of course results in a dilemna for those who are in wheelchairs and on the upper floors. There is no other alternative but to use the stairs. Glendon Hall poases a major obstacle because of the many winding stairs and steps. The offices on the second level, the pub and Radio Glendon are inaccessible. The step before the doors of the bookstore and the narrowness and heaviness of these doors make the bookstore not easily accessible for an unaccomnanied person in a wheelchair Doors and washrooms in York Hall, the cafeteria, the Bistro and Frost library do not present

difficulties according to Tania. Changes have begun (as much as a year ago) to facilitate access to Glendon's buildings. Due to a grant received from the government. Gilles Fortin, Dean of Student Affairs, stated that electric doors were installed at the main entrances and in the hallways of York Hall. Hilliard Residence received two electric doors and a new door to A-House, the keyhole and handle of which were lowered There is a room in a A-House with a wider doorway and a washroom for the physically disabled (although it is not located in A-House). Also, a side entrance and ramp to Frost Library were added. Other changes in the past include the construction of the path from the breezeway to Hilliard Residence, additional parking facilities for the physically handicanned and lowering of elevator buttons in York Hall. The future Business Office and Security Office location at the U. of T. Greenhouse building already has a newly constructed ramp for wheelchairs

Gilles Fortin pointed out that money for the improvement of of facilities for the physically disabled depends mainly on government funding, and that changes such as making Proctor Field House wheelchairfriendly, or providing some kind of transportation between the upper and lower levels, or installing an elevator in Glendon Hall would involve a very large amount of money. Alterations to Glendon Hall are especially difficult because of its age. The some problem is being faced by the University of Toronto, Gilles Fortin said. If any students have concerns they should not hesitate to contact the Office of Student Affairs. Overall, Glendon's facilities for the physically handicapped were given an okay rating by Tania Sala

## **Gulf Crisis affects Glendonites**

Controversy has developed in recent days over the appointment of a Glendon student to the paid position of Facilitator of the Glendon Food Services Committee (GESC).

The new Facilitator, Claudine Pilon, is an off-campus student who, admittedly, rarely uses the food service facilities at Glendon. Fears that Pilon would not be able to properly represent the student's concerns arose. Pilon was quick to defend her new position saying that the appointment of an offcampus Facilitator will be an "added bonus". "Those out of residence will be represented and I will see things that you guys don't".

Pilon explained at the last GFSC meeting that the position is one of "glorified secretary" and that it was a position that was "unimportant". She said the Facilitator's job is to take minutes of GFSC meetings, write the Au Menu column for *Pro Tem.* organize meetings and do various clerical work. and not to represent individual's concerns. Glendon Business Manager Loon Wasser said the position was to "make sure communication happens between the committee and the student community".

Wasser himself hired Pilon for the job. The Facilitator position was advertised through the Student Placement Centre and Pilon's application was the only one to be received. Wasser feels that Pilon is the best person to fill the position despite the fact that only one application was received. He cites her two years as chair of the GFSC as more than enough experience for the position.

Pilon discredits fears that she will be unaware of the problems of those students who use the food facilities more often by saying. "I still scan the cafeteria each time I go in, for things that might be wrong". Pilon says she understands the problems of residence students because she was one for two years and she will never lose sight of that.

Peter Stathis, editor of Excalibur, explained that Monday morning, soon after Excalibur was released, they received a series of letters and phone calls complaining about the racial and stereotypical nature of the editorial cartoon. A decision to pull the paper immediately and reprint it in

Glendon Campus is among the safest places in Metro Toronto to work, live and study. But Glendon is only as safe as we decide to make it.

Eliminating the opportunity for crime is the first step in crime prevention and that means all of us will be safer Awareness combined with common sense equals peace of mind for us and our neighbours.

I just want to mention a few crime proofing pointers that I found in a pamphlet prepared by the Ministry of the Solicitor General.(1)

These pointers apply to all of us whether living at one of the residences or off campus.

Answer the following questions and see how you rate:

### Your Home

- Do you always lock your doors when you leave your house or room, even if it's only for a few minutes?
- Do you leave your I eys hidden in obvious places?
- If you return home and suspect someone is inside, do . you enter alone or go to a neighbour for help?

### Your Life

- Do you hitch-hike? Once inside a car, do you know how hard it is to get out?
- On foot or by car, do you always determine the safest route to your destination?
- Do you avoid dark and deserted areas?
- Do you always take the shortest way even if it isn't the safest, because you want to save a few minutes?
- Do you always let people know when you leave and when you plan to arrive?

Here are a few crimeproofing pointers for the campus

- Call security immediately if you spot strangers loitering around the campus for no obvious reason. We'll respond.
- Report if you see a stranger walking through the buildings testing to see if doors are locked. He probably isn't there to make sure the doors are locked.
- If you hear the sound of glass breaking or if you see somebody around the parking lot looking into cars or trying to tamper with them, tell security. We'll investigate.
- Never let anybody into residence unless he or she is your guest. Even if you know the person, have him or her wait until admitted by the person who issued the invitation.
- At night, especially when you are alone, call the student escort service and they'll take you to your destination even if it is on campus. There is the foot patrol if the van is tied up and they will be glad to help you out

If you have any questions or see anything on campus you think may pose a threat to our safety and security, let the department know and we will try to remedy the situation. Remember we are on the job 24 hours a day. Don't hesitate! 

## North York Reviews Zoning By-law

The City of North York is presently embarking upon a major revamping project of its Zoning By-Law 7625. The aim of this five year review program is to establish a new and easy-to-use document, for today and the future, in a city that is quickly expanding.

Mayor Mel Lastman writes regarding new development, 'The downtown skyline on Yonge Street north of highway 401 is being transformed into Metropolitan Toronto's newest, most modern and most sought after commercial centre.'

Glendon College is built in North York within a Greenbelt Z. nc. A site specific by-law enacted on October 27, 1960 allowed York University to operate a residential campus on this location.

So although, the review of different Greenbelt areas during phase three of the program will not begin for at least a year to a year and a half. Glendonites should now begin showing their commitment and interest in the management of these areas, particularily our valley. Perhaps even Glendon College should demand a voice in the program when Greenbelts are to be discussed.

Among the major changes, though definitely not all of them, that Councillor's and Planning Department staff would like to see are the removal of obsolete previsions from the document and the addition of detailed mapping. This last recommendation when implemented will facilitate the comprehension of the locations of different zoning areas throughout the municipality.

The current Zoning By-Law #7625 was first put into use in 1952, almost 40 years ago. It is now out of date.

As well, the nearly 3000 amendments that have been made to the by-law since its implementation have filled the document with many inconsistencies in definitions and site guidlines. It has become unwieldy for civil servants and planners who work with the document daily, and virtually incomprehensible to a layperson.

A part of the first phase of the review included four public workshops that were to outline the project to North York citizens and identify their concerns. Only a total of approximately 40 to 45 residents attended the meetings. During a telephone interview, Project Planner Nimrod Saloman described the public's interest up to this point as limited. He suspects that participation will increase as the review program, begins to recommend particular amendments to the Zoning By-Law because these will concern individual citizens more directly.

A Zoning By-Law is enacted ny Municipal Councils in order to restrict and regulate the use of land for compatible purposes within the municipality and the way buildings are constructed. It specifies building standards including lot coverage, setbacks, density, building height and parking requirements.

To be legally valid a zoning by-law must comply, within Metropolitan Toronto, with the Official Planning Act. Nor can it prohibit the function of a property still in use under the criteria of a prior by-law. A by-law should equally exclude subjective criteria.

## Making Glendon More Secure

Recently, I was talking to Don Magee, Director of Security at Glendon, about the move that the Security Office was going to be making to the Greenhouse. While we were talking, he told me about several improvements to the system that will be made as soon as possible, some the same day that they move.

First, they are moving out of an office that is far too small, as I saw when I went to the office in C-Wing. With an administrative assistant, Magee, and one Security Guard in there doing paperwork, that office is full. When Karine Morin, E-House Hilliard Don goes in to help with the paperwork, the Security guard has to go. As officer Vince DiPinto said "If we put a Fax machine in here (Mr Magee's) desk would have to go out the window".

The new facilities will include a large general office, where students and staff will be welcome to drop in to ask questions, or get help. There will also be a permanent office for Student Secsurity and even a small kitchenette. Magee has said that he hopes the office will become a drop-in centre for information. He plans to have T.T.C. schedules and information, maps and crime prevention information available soon.

There will be someone in the new office every day and until at least 2:00 am every night starting the day Security moves to the Greenhouse, December 3, 1990. They will be able to do this because the Student Security team will always have a supervisor on duty who will stay in their office until the end of the shift. After 2:00 am there will be a guard available as often as possible in the office, however, if something does happen on campus, the guards are not supposed to go alone, so there may be times when the office will be empty.

Soon there will be eight Security Officers, there were only five last January, and there are six now. Hiring two more officers will mean that there will always be two officers on duty, even after 2:00 am. Magee aiso wants to get a bilingual female officer. We had a female officer on this campus for a while, and the female students seemed to find her easier to approach than the male officers. Uniortunately she was unilingual (English) and could not be kept here on a permanent basis. Magee hopes to get someone like her who speaks both French and English soon.

In the meantime, please remember that the other officers

are ali approachable and very willing to help where they can. The main concern of our Security office (despite our suspicions about their fanaticism over parking tickets) is the safety of all the people on this campus. So let them know if they can help you. For those in residence, remember that if you are not comfortable talking to a security officer about something, your Doncan help. Everything is confidential.

## Reflections on violence against women

I've spent a year reflecting on the nature of a society where women are often afraid for their live. A society where women can't walk the streets alone at night, and often aren't even safe in their own homes. Rape, sexual assault, molestation, and partner abuse affect many women. There is no discrimination on the basis of age, looks, sexual orientation, religion or marital status.

I speak from the experience of being sexually molested over a period of several months when I was five years old. I was molested by a group of older boys in our neighbourhood. They made me go with them to a nearby gravel pit where I was made to kiss and suck on their penises. I wasn't sure why they made me do it, but knew I had to continue or I would get in trouble. They told me they would tell my mother if I didn't keep doing it, and fearing her reaction I continued.

I remember bringing a note home from school and showing it to one of them. (At five years old I really believed they were my friends). I asked him what it said and if I had to show it to my mother. He told me if I didn't then he would tell her what I do to them, and that I would get a spanking for it. These memories were all blanked from my mind for ten years. It wasn't until I entered into my first relationship that the memories came flooding back. I was lucky though. everything I do remember is rather vague, and when I first started dealing with these memories I was surrounded by supportive people. Many people

aren't that lucky and their scars are more serious than mine.

I still have questions about what happened though. I don't remember how long it went on, or when and why it stopped. These are questions that I don't often know if I'al ever find the answers to. In some ways I hope I do learn the answers, but I still have fears.

Coming out over the past year as a hisexual lesbian feminist has really influenced my thinking. I've learned just how much sexism and homophobia there is in today's society. I would have thought that a University campus would contain individuals who are mature, and well-educated. Unfortunately, if the attitudes my girlfriend and l experienced are indicative of the general thoughts of Glendonites then this campus is extremely oppressive. Sexism, ageism, ra-

cism, homophobia, ableism etc., are all forms of violence. We as students, faculty and staff of Glendon need to work together and to individually combat all of the "isms" in our society. Take some time ex-

pecially on December 6, to reflect on violence, and what it means for

our society, and more particularly what it means for women.

P.S. I decided to sign my name even though, or maybe especially because, this type of article usually comes unsigned. I am comfortable with my sexuality enough to let the whole campus know it. And I am secure enough right now to realize that the molestation that occured when I was five was not my fault.

Many important issues face women today: violence, sexual harassment, AIDS, and their roles in our changing society are just a few. With these issues come a need for support services to help women cope. Women's centres are very important in satisficiant there each as then are one of the few places.

important in satisfying these needs, as they are one of the few places designed to serve **women**. first and foremost. With a student population that is 73% female. Glendon is fortunate to have two

women's centres on campus. However, this writer wonders how aware students are of the resources available to them, after interviewing five Glendon students.

The students were asked five questions, as follows:

 Did you know that Glendon nas two women's centres: the Glendon Women's Education and Referral Centre (GWERC) and Le Centre de Recherche et de Ressources Pour

Femmes (CRRPF)? 2. Do you think Glendon needs two centres?

- Why? 3. Have you ever used the resources of either centre? Have your friends used them? Which centre did they v ve?
- 4. In your opinion, is the Glendon College student body deeply concerned about women's issues as a whole?
- Do you believe (if it was possible) that Glendon College would be better served by one bilingual central organization for education, research, resources and referral?

Here are the responses of the interviewees:

Jennifer Jackson, Year 1, Psychology Major

I. I only knew about the GWERC.

2. If we have two centres, they should both be bilingual, since Glendon is a bilingual campus.

3. No, and none of my friends have (used either centre).

- It is a fairly liberated student body, and I guess they are deeply concerned.
  Yes, I do, because it would decrease overall expenses, and one big centre would
- be better organized.

### Minerva Hernandez, Year 3, International Studies Major

1. No. I only knew of the GWERC.

- I think we need ity two as we need a service for francophones by francophones. Francophone women may feel more comfortable speaking to other francophone women.
- 3. No. I have used neither centre and I do not know of any friends who use it.
- 4. I think it is, but it's not really (as concerned) as it should be. A lot of people criticize and crack bad jokes about the Women's Centre (GWERC). It gets a bad reputation. People talk about them (GWERC), but I don't know if they're concerned.
- I think it would be much better as long as they have francophone service for francophones and anglophone service for anglophones.

### 'A francophone male', Year 3, wishes to be anonymous as he doesn't like to 'get involved in women's issues'

- I. No.
- 2. If there's a demand for the services, we need both (centres).
- No. None of my friends have used them; I didn't even know such a thing existed (women's centres at Glendon).
- I've never thought about whether they are concerned or not (about women's issues).
- If there's a need for two, but maybe both should be put together to make it bigger and more effective - better services through one. Maybe it could become a centre to serve the area, not just students.

### Natalie Srdic, Year 4, English Major

- I was aware of neither centre.
  Since they seem to have different purposes (from their names), they are both necessary.
- 3. No. No. (my friends haven't used the centres) not that I know of
- Yes, I think so (that Glendon students are concerned). All the things, considering the female-male ratio, mass-majority women. Women's groups are the most visible and active on campus.
- 5. I think it would be better for them (the centres) in terms of being known on

campus if they were one. They do have a common basis involved. I have a problem with the fact that there is a francophone only centre on campus-both should offer bilingual services. Every other service or office is bilingual. They strive to be accessible in terms of language. It's really perturbing. It's only small starting points like that that begin francophone-anglophone animosity.

### Joni Sharkey, Year 2, International Studies

- No. I did not know there were two centres. I only knew of the GWERC.
  I Jon't know what the francophone centre is involved with: therefore, I can't
- say if the GWERC and the francophone centre are both necessary.
- 3. No. None of my friends have (used the centres) either, that I know of
- I wouldn't say they are deeply concerned, but I would say they are concerned.
  Yes, I think so, because it would be a unified structure of services for women at Glendon.

Surprisingly enough, no one in my completely unscientific, nevertheless valuable, sample of the Glendon student body had used either centre. Neither had any of their friends, and not one of them knew about the francophone centre. Certainly one can't generalize on five interviews; however, it is likely that a significant proportion of the student body would give similar answers. At the very least, it -reast shat five students were not aware of two very important centres. Even one student without this knowledge is a tragedy, as she could be the one in a crisis situation someday, needing the help that the centres offer.

A lack of information and - ome confusion exist about the centres. To alleviate the problem, interviews were conducted with a representative of each centre, and materials describing their goals and activities were obtained. From these, it is evident that both centres are very different and necessary to the Glendon community.

Le Centre de recherche et de ressources pour femmes est situé au burcau 301, Manoir Glendon, Le centre lait partie du Réseau des femmes du Sud de l'Ontario, qui a vu le jour en 1982. Le plan d'action du Réseau comprend la prévention de la violence et le développement communautaire. Il a mis sur pied ces dernières années trois services. La ligne SOS femmes, qui répond aux appels de détresse et informe, dessert la région de Windsor à Belleville et de Niagara Falls à Parry Sound. On peut

téléphoner sans frais d'appel au 1-800-387-8603, de 8h30 à 19h30, du lundi au vendredi.

Le Centre de recherche et de ressources à Glendon a été créé à la suite d'une entente entre le Réseau et le Collège. Glendon offre son appui et un local. Le but du Centre est de réunir un grand nombre de ressources écrites sur les femmes, de constituer une banque de personn. -ressources francophones et de favoriser des rencontres à but de travail, de discussion ou social. Ina Motoi est la co-ordinatrice générale du Centre et Roxane Thiburee en est la secrétaire-bibliothécaire. Le Centre n'a pas été créé seulement pour servir la région de Toronto, mais vise à atteindre également le Sud de l'Ontario, afin de faciliter et appuyer le travail communautaire du Réseau des femmes du Sud de l'Ontario.

In the interview, Ina Motoi of the CRRPF said that it would be impossible for the GWERC and CRRPF to form one centre, as they each have different goals and mandates. As well, the CRRPF reaches across Southern Ontario, while the GWERC focuses only on the needs of students at Glendon, and it is a bilingual organization, not solely francophone. The CRRPF does refer anglophones to other services, but GWERC offers peer support to anglophones and also to francophones, who constitute about 25% of their inquiries. When asked, Barbara Nash, one of the founding members of the Glendon Women's Education and Referral Centre, commented "I feel both centres give valuable service to their respective constituencies". This comment certainly summarizes what was discovered while researching each centre.

> No one in our sample of the Glendon student body had used either centre. Neither had any of their friends, and not one of them knew about the Francophone Centre.

## Getting addicted to Jane's

God bless Los Angeles, the city that has spawned several of today's modern icons of a secula: and more practical gospel, preaching not through religion but through electric guitars.

But even those born in the ity of Angels counter the Commandments from time to time. Most certainly those Commandments laid down by an uptight society. With the release of their third album Jane's Addiction has fallen victim : 2t again to the ignorance of censorship (their second albam Nothing's Shocking was sold in black plastic bags in the U.S.). This time it was Canada who took offence to Perry Farrell's (lead singer of Jane's) creativity. Upon its release Ritual do lo habitual's original cover was censored here at home and thus a plain white cover bearing the name of the group and of the album and a blatant reprint of the first amendment was substituted.

But a change of heart (or was it a rude awakening to the importance of the preservation of freedom of expression) on behalf of the censors has impelled a recent domestic release of the initiatory artwork. Thus the original *Ritual* is now available in Canadian record stores. Check it out. If you don't like it, don't buy it. It's

that simple. If you don't understand it, buy it anyway just so that you can read the very eloquent letter written by Perry Farrell to those responsible for the banning.

Surprisingly, the U.S. opted not to completely censor Jane's this time around (both album covers are available for purchase). Yet they did feel that it warranted a "Parental Advisory of Explicit Lyrics" sticker due to a sprinkling (and 1 stress an ever-so-light sprinkling) of mother fuckers. Come on, even Billy Joel said "fucking" on his Nylon Curtain album.

Why is it that the steady

emergence of intelligent, enlightened musicians who are willing to speak out against racism, violence and other social concerns has so enticed those favouring the censorship of art of all forms to crawl out from under their rocks?

Despite the concerns of the supporters of censorship with regards to the accessibility of Jane's questionable lyrics in its pre-recorded form, there were no qualms of setting up Canadian dates to accomodate the *Ritual de lo habituai* promotional tour. No warning of explicit lyrics appeared on my ticket for this past Sunday's sold-out show (an all-ages one at that) at the Concert Hall here in Toronto. Well, if they insist upon being imposingly ignorant with regards to censorship at least they're not being annoyingly thorough about it.

The opening band, the Buck Pets served as a well received warm-up to the swarm of moshers and stage divers on the floor. Their set lasted a good forty-five minutes, a long time for die-hard Jane's fans to wait.

As the Buck Pet's equipment was being carried off stage, the dry ice machines started to spew and the lighting came alive. As the purple haze dispersed, we were exposed to a stage overflowing with candles, religious paraphernalia, dolls, plastic fruit, etc. Stuff you would probably find in Perry's bedroom. And yes, the stage was prepared with the Christmas lights, only this time not for Xiola but for us.

"Up the Beach" off of the album Nothing's Shocking opened the show. Soundvise, Perry Farrell along with Dave Navarro on guitar. Stephen Perkins on drums and Eric A. on bass managed an impressive studio quality for a live show. The playlist was a heavy one. A selection of tunes from all albums were raunched out to perfection. "No One's Leaving", a song that slams racism of any expression was exceptionally well performed. Renditions of "Three Days" (Farrell took out his twelve string for this one) and "Idiots Rule" left a kink in my head-banging neck and a lump in my throat, while tunes such as "Ted. Just Admit It" had full-grown long-hairs singing along with Perry on the floor.

The stage rushing that occurred in no way offended the band members, who seemed quite at ease when members of the audience would jump up on stage, hug whoever was clesset, and then dive back onto the floor. Perry even reminded the audience to catch any stray stage divers. Even "Summertime Rolls" was sung smoothly by Perry, while an enthusiastic fan wrapped herself around Farrell's body.

A powerful performance of "Mountain Song" was to end the show, but a hopeful and noisy crowd induced Jane's Addiction's encore, "Ocean Size".

Perry Farrell is tremendously endowed with a talent to command an audience. Between tunes he spoke with the crowd, easily winning them over with his charm and intelligent wit.

"You shouldn't hope, you should just wait to be pleasantly surprised." Farrell advised. Is it words such as these that warrent censorship?



## Pub protests liquor sales at Ball

The Café de la Terrasse expressed at the last Glendon Food Service Committee (GFSC) meeting that they should be the ones to serve the alcohoi while students dance the night away in the cafeteria at the upcoming Christmas Ball.

Michèle Boissonneault, the Café's Board of Directors Chair, expressed her opinions concerning the issue at the last. GFSC meeting on November 27. She said, "It appeared to me to be a compromise in the best interest of the students".

Boissonneault went into the meeting to make her point on why she personally felt it would be best for the Café to serve 'he drinks once the meal was over. According to Boissoneault the Café would be better because the Café is student-owned and operated and any money brought in from the sale of drinks would benefit the students.

Glendon Business Manager Leon Wasser said that the main reason why the catering firm. Restauronics, was chosen to serve the alcohol is that "the caterer has the first right of refusal of catering to the cafeteria". This means it is given first priority over the Café wher. events are held in the cafeteria.

Wasser also noted that when the process of negotiating prices for the 'Christmas' Ball took place, the sale of alcohol after the meal was taken into account by the caterer. Lou Salem, the Manager of Food Services for Restauronics, decided that the caterer would take a loss with the sale of the meal at fifteen dollars a plate. This loss was to be offset by profits made by the sale of drinks afterwards.

The second reason why Boissoneault felt that the Café should serve drinks was because its staff is better experienced and all staff is trained under the Server Intervention Program (SIP). The SIP program trains people how to serve alcohol in a way that reduces possible problems from arising. It also teaches staff of the liabilities involved with serving alcohol.

There are three or four people trained under SIP that will be
